Tacoma Pierce County Coalition to End Homelessness American Rescue Plan Act Priorities

Goal: Invest in long term housing and organizational assets and meet immediate needs. Priority: Households below 30% AMI; organizations with operating budgets below \$1M/year. Note: All expenses must be COVID-19 related and meet federal ARPA requirements.

Housing

- 1. Acquisition of 1000 existing units of housing @\$100K/unit \$100M
- 2. 250 hotel rooms for five months FEMA Public Assistance B \$0* (Not ARPA)
- 3. Forward rent for 500 homeless households @\$10K/household \$5M
- 4. Set up 20 self-managed encampments \$1M
- 5. 100 Safe Parking sites \$1M
- 6. Develop 500 rooms in a shared housing model that are certified at code and follow all tenant protections. \$1M
- 7. Prioritize new Housing Choice Vouchers for households below 30% AMI
- 8. Inspect, upgrade, replace HVAC systems in all congregate shelters \$2M
- 9. Move in expenses for each new voucher TBD
- 10. Money to pay off judgements in eviction cases TBD
- 11. Ensure relocation of low-income tenants in any acquisition is covered TBD

Health

- 1. Scheduled weekly testing and vaccinations at each congregate shelter and encampment of 20 or more people.
- 2. Training and support for 50 Street Medics for encampments \$500K
- 3. Materials for on-going outreach testing and vaccination campaigns \$24K
- 4. Increase mobile and Telehealth services especially for women's health clinics and federally qualified health care centers.

Services

- 1. Vehicle repair, licensing, insurance for 100 homeless households \$100K
- 2. Garbage services for encampments- \$1M
- 3. Transportation: bus vouchers, gas cards TBD
- 4. Technology: access to broadband, cell phones, tablets TBD
- 5. Increase funding for Human Trafficking Prevention TBD

Staff Support

- 1. Housing benefit for 100 staff below 50% AMI \$1M @\$10K/household
- 2. Forward hazard pay for 200 full time shelter and outreach staff below \$20/hour @\$4/hour x 2000 hours \$1.6M
- 3. Individual financial counseling especially re the "benefit cliff." TBD

Organizational Sustainability for 501c3 Nonprofits

- 1. Financial management support for contracting with local jurisdictions to handle federal funds. Priority to organizations with pre-COVID operating budgets of \$1M or less. 100 nonprofit organizations @\$10K@ \$1M
- 2. Cover interest on cash flow loans for reimbursable government contracts \$1.5M
- 3. Ensure adequate back office support for small nonprofits TBD
- *. FEMA Public Assistance B is not part of ARPA
