How should our community respond to ensure that those who are homeless with disabilities have equitable access to shelter and resources? Group Discussion Summary • Tacoma Pierce County Coalition to End Homelessness • 9.15.23

Issues/Questions to Consider

- How are TACID and other organizations approaching needs of racial/ethnic communities and indidividuals who may feel distrust because of racial bias and cultural differences.
 This may apply to members of tribal communities and other groups -- given the history of racism, displacement, medical bias, etc.
- Noted unique challenges of people with disability such as difficulty setting up a tent -and that this is common.
- What about people considered "too well off" to get certain services, but need too much
 care to get into a shelter or use other services. This midrange group may have particular
 challenges getting access to services. This relates to people refused access to shelters
 because they are told there is nobody to help a person with these needs.
- Overall, lots of new people added to HMIS who exceed the number of shelter beds.
 Concerned that they are moving outward -- where they may feel safe to set up a tent and not be mishandled.
- Would Adult Family Homes (AFH) be a good place to serve folks w/ disabilities who are living on the street but want shelter?
- Is there anyone doing street outreach that can help folks with disabilities to understand their benefits, help them connect w/ DSHS if needed?
- What are the laws/policies around who a shelter has to let in? Is there a way to support shelters to build capacity so they can accept folks with more challenges?
- We're not dealing well with the individual; challenges that people on the streets face. One size does not fit all.
- Seems to be a disproportionate of people on street that have wheelchairs and other mobility devices.
- People develop disability from stresses of street.
- Discussed importance of trying to have medical staff at congregate shelters to address and assess the needs of those served by the shelter.
- Discussed potential conflicts, overlap, of determining the roll of the shelter staff to address disability.

Solutions Offered

• Even though TACID's mission isn't directly related to homelessness, their voice in advocacy will be helpful.

- Intentionality in language & rhetoric to wider community.
- Consciousness raising campaigns because the wider community is unaware of the barriers & lack of resources if it doesn't touch them directly
- Could we have someone from DSHS or one of the insurers (e.g. Molina) who understands this system, come speak to our group?
- There is a critical need for Case managers to be readily available with a reasonable case load to determine needs surrounding their disability(s).
- We need to march in the streets. A lot of frustration with elected and their failure to pay attention. They are not dealing with reality.
- We need more mobile outreach and New Hopes.
- We need to put up candidates to challenge our elected. They don't pay attention to anything that's not on fire. We need to light this issue on fire for them.
- Need resource providers under one roof on a permanent basis especially for those with disabilities so that they are not forced to travel from one location to another to avail themselves of the service.
