Definitions

Shelter – temporary places to live that provide protection from the weather, bathrooms and hand washing on site, and access to on site or off site laundry, food or food preparation, storage for possessions and showers.

- **Communal Sleeping Shelter** Shelter where sleeping areas are shared by multiple households. Large dormitories or gymnasiums fit in this category.
- **Private Sleeping Shelter** Shelter where households have private sleeping rooms, but bathrooms, showers, and dining/food preparation areas are shared. Tiny houses or churches with separate rooms for each family fit this category.
- **Apartment/Hotel Shelter** Shelter where households have private sleeping, bathroom, shower and often dining/food preparation spaces.
- Sanctioned Parking or Encampment A place individuals can live in cars, RVs, tents or tiny houses. Bathrooms and hand washing stations as well as dining/food preparation is available on site. Showers and laundry may or may not be available on site.

Wet Shelter – Shelter where alcohol and drug use is permitted in private spaces – no sale or distribution on site.

Clean and Sober Shelter - residents are expected to abstain from alcohol and drug use



Shelter Design Discussion Questions

- 1) Should households with minors be separated from households with only adults.
- 2) Should households with parents and young adult children be treated as families or adults?
- 3) Can single adults and families share the same shelter facility?
- 4) Do we use a percentage of the HMIS currently homeless count for our shelter target or the full estimate? The data says we more than triple the size of our shelter system.
- 5) Do we use where people are from as the guide for where shelters should be, or the location they are currently living
- 6) We are looking at breaking shelters into 4 distinct types. How much of each one should we push for?
 - a. Communal Sleeping
 - b. Private Sleeping
 - c. Apartment/Hotel
 - d. Sanctioned parking/encampment (designed to evolve into tiny house villages)
- 7) What should the breakdown between wet (low barrier) and clean and sober shelters be?
- 8) Should we have wet shelters with families?
- 9) Is Orting close enough to Bonney Lake to consider a single shelter for both cities? How far to travel in rural areas?
- 10) Should we have a very large site like something over 200 units, or over 500 units?
- 11) Should we look at the Austin Model to start or to evolve to 100 mobile homes and 130 tiny houses on a 25+ acre site?
- 12) Will the estimated 600 people living in cars want to remain in cars? Or will only 300?
- 13) How large should a safe parking site grow to?
- 14) Should RVs be allowed in safe parking, or should designated RVs sites be created?
- 15) What do we do about the 150 youth and young adults across the County? Are there more we don't connect with? Do we do dedicated sites or serve in other shelters?
