- Mike Yoder Noticed discussion of whether to have Unified Regional Office in the County or with an outside consultant was that expected
- Gerrit yes the Council is split, but I'm hoping they come to an agreement so that it is a unanimous passage
- Rosemary communication is a clear priority in pulling this plan off what should be the Coalition's role?
- Theresa I'd recommend we not plan for Gerrit to do all that communication. (*appreciated -ed*) We do a good job inviting people in especially that we consider everyone welcome.
- Theresa there is a need for coordinated action and advocacy. We don't need everyone to decide to support one thing.
- Rosemary we can provide facilitation of coordinated action.
- Ed who should be on the Pierce County Comprehensive Plan Advisory Board? We need to make sure the underrepresented included. We need to talk about who should be on that.
