## Site Rules Agreement

While staying at the CAMP HOPE - Temporary Shelter Site, you are agreeing to the site rules and requirements. You are also agreeing to be a "GOOD NEIGHBOR" while at the site. This Site Rules Agreement is entered into between you, \_\_\_\_\_\_, a shelter participant, and the SHELTER (site hosts). This agreement is dated \_\_\_\_\_\_, 20\_\_.

AS PART OF BEING GRANTED PERMISSION TO STAY AT THE SITE, YOU AGREE TO THE FOLLOWING:

### Site Rules:

- You will agree to fill out all paperwork and receive a site identification badge;
- You will agree to follow all site rules and requirements;
- You will follow all laws when you are at or around the site; you understand that laws will be enforced onsite;
- No individuals under the age of 18 will be allowed at the site;
- No families with children are allowed to stay at the site;
- You will not engage in any predatory behavior at or around the site (drug dealing, stealing, sex trafficking, assaultive or abusive behavior);
- You are not allowed to possess, use or consume drugs or alcohol on the site;
- You will only store your stuff (your personal belongings) within the boundaries of your assigned space;
- Visitors are allowed at the site during operating hours and in specific locations;
- You will follow all curfew requirements;
  - Curfew is from 8pm 8am
  - No visitors
  - Quiet time at the site
  - No coming and going from the camp
- You will not bring any illegal weapons onto the site; you will not brandish or threaten anyone with guns, knives, or other weapons in or near the site;
- You will stay out of other participants areas and belongings;
- You will dispose of all trash in the trash containers;
- You will keep the bathrooms and other spaces clean;
- You are also agreeing to working with staff to come up with a housing/stability plan;
- You are eligibility to stay at the site will be assessed every 30 days. Extensions will be based on your level of engagement in services and availability of housing/shelter;
- There will be no physical contact with staff or other clients in this facility;
- You will not move, adjust or compromise the perimeter fencing at the site;
- You will be a "Good Neighbor" and follow all direction from staff;

## Site Rules Agreement

#### **Good Neighbor Policy**

- You will follow the "Good Neighbor Policy" which requires you to respect your neighbors in the shelter and at and around the neighborhood. The policy is simple, treat others like you would like to be treated. It also includes:
  - Follow the curfew and quiet hour rules at the site
  - Clean up all outdoor areas around the shelter
  - Respect the property and surrounding neighborhood
  - Not gossip about other shelter participants
  - Not gossip about shelter staff
  - Not destroy or vandalize shelter or others property

### IF THESE RULES ARE NOT FOLLOWED, IT MAY LEAD TO YOU BEING ASKED TO LEAVE THE SITE.
